<u>TABLED RES. NO. 177-19 –</u> Acceptance of Funds from NYSDOT for the Rehabilitate Hangar C (NYSDOT/Aviation Grant Program) at the Chautauqua County/Jamestown Airport

Chairman Wendel: We have a motion by Legislator Nazzaro, do we have a second?

Legislator Chagnon: Second.

Chairman Wendel: All those in favor to bring this off the floor, please signify by the usual signs.

Unanimously Carried

Legislator Nazzaro: On our desk was laid an amendment, so I'd like to make a motion to amend the resolution that was tabled by substitution.

Legislator Chagnon: I will second the motion to amend.

Chairman Wendel: Thank you. We have a motion and a second, all those in favor signify by the usual sign.

Unanimously Carried

Chairman Wendel: At this time is there any discussion on resolution 177-19 as amended?

Legislator Nazzaro: There has been a lot of discussion on this in both Public Facilities Committee, Audit and control, as well as in leadership. In the July meeting I made a motion and it was approved to table this so we could get additional information regarding the airport. After the meeting our Director of Public Facilities, Brad Bentley, came up to me and asked what he could get for us. So, first of all, I toured the airport. I went up there to the Chautauqua County Airport. I've been there many times, but I saw parts of it I had not seen before, specifically, this hangar, which is very old and used to be owned by the refinery in Warren- United Refinery. It's in terrible condition. So, the challenge that myself and Legislator Chagnon gave to Brad Bentley and Ron Almeter at the airport was that we cannot support the use of almost \$172,000 out of the capital reserve. We have many projects that are critical, but after much discussion we could support the use of \$50,000 out of the capital reserve. So, the challenge to them was to come up with other mechanisms to pay for this because as you know, we're getting a state grant of over \$900,000. So, the resolution that we substituted here shows in red the local share is now \$50,000 and not the \$172,000. Also, we have in-kind services to be performed in 2020 of \$48,000 and both Brad and Ron provided detail sheets of that and I'm comfortable with that. They're going to have timber sales on airport property, which have to be used for the airport; they can't be used for anything other than the airport-\$65,000. There's a small amount here for salvage of the value of the hangar and sale of surplus airport property of nearly \$8,000. So, they met the challenge. We're going to be taking less out of the reserve, and as we all have heard, if we do nothing it will cost approximately \$80,000 to tear it down. So, we can either spend \$50,000 out of the reserve and have a million dollar renovation project that can be rented out to private companies or we can spend \$80,000 and have nothing. I strongly encourage the legislators here to support this amendment. Thank you.

Chairman Wendel: Anymore discussion?

Legislator Niebel: Mr. Chairman, Chuck has done a good job of explaining the numbers in this particular instance. It does save us money in the short term to approve this resolution, but long term, look, I think we have to address the issue of supporting two airports. Looking ahead we may be asked to support a fourth fly car later this year. I think we need to decide what's more important; the convenience of having an airport in the north and southern part of the county, or the public safety of our county residents. In this particular instance, because of the savings that Chuck has just proposed for this hangar, I will support this.

Chairman Wendel: Thank you. Anyone else to speak to this resolution? All those in favor signify by the usual signs.

Chairman Wendel: At this time we will have a vote on local law 4-19. All those in favor signify by the usual signs.

Legislator Chagnon: I'm sorry. The correct number now is \$174,834. I'm sorry, I read the 2019 number. Thank you for pointing that out.

Chairman Wendel: I just wanted to make sure it was clear for the record. We have a motion to amend and second. All those in favor to amend signify by the usual sign.

Chairman Wendel: I'm going to break from protocol for this one, if I could. We have several members in the audience this evening who would like to speak to an event being held this weekend that does represent and help out our fellow citizens with childhood cancer.

Tera Swan: I appreciate you inviting us to speak this evening. 43 children per day or 15,780 children are diagnosed with cancer annually in the U.S. 1 in 285 children in the United States will get diagnosed by their *(inaudible)* birthday. The average age of diagnosis is six years old, compared to 66 years old for adult cancer diagnosis. Childhood

cancer is the leading cause of death by disease in children. I don't need to recite these statistics to you. Pediatric cancer is a national concern and unfortunately we are seeing it more and more here in Chautauqua County. Kallie's Krusade is one of hundreds of nonprofit organizations that focus on helping children with cancer, as well as assist their families with educational, emotional and financial support. Too many children are affected by this deadly disease and more must be done to raise awareness and find a cure.

Kallie is my daughter, who was diagnosed at 21 months old with acute lymphoblastic leukemia, a common form of pediatric cancer. Prior to her diagnosis, those words held no real meaning to me. I didn't know that they would consume my life and eventually end up taking my daughter's. Kallie Lynn Swan passed on May 6, 2015 in her home, held in my arms, next to her Daddy along with her dog and surrounded by her family. Kallie had fought a courageous battle with lymphoblastic leukemia. Even amongst the challenges she faced in her short life, Kallie upheld a spirit *(inaudible)* and perseverance. She was always concerned about the comfort and happiness of other children *(inaudible.)* She was a lesson to all of us about love and hope and although she endured months of treatment, she never let any of it dull her sparkle or fade her smile and because of that the foundation lives on. We continue to fight like a girl against pediatric cancer.

Here tonight, I have two families- the Gibbons- Lucas, who has been dealing with retinoblastoma and then Drake McKane and his mom, who is also dealing with leukemia. All of us in this room have experienced some type of loss. You may have lost a child, a parent, a spouse, a sibling, a relative, or a friend. Not only did we lose our daughter, but we lost ability to parent her on this planet. No hair braids, no school work, no packing lunches, no field trips. She died and so did all of those moments with her. I lost all the things that she was and would have been- an artist maybe, a writer, a clerk, a doctor, a mother with her own children. These children here and these families have lost so much because of pediatric cancer. So, on behalf of all of us, we thank you for recognizing pediatric cancer awareness month during the month of September.

Chairman Wendel: This Monday there is going to be an event held throughout the *(inaudible)* beginning at 9 o'clock in Lakewood. This is being spearheaded by Tera and her husband and many other people. *(Inaudible)* This will be a tremendous event, so I just encourage everyone if you are in and around Lakewood sometime on Monday, please come out and support Kallie's Krusade. It's an incredible event. Thank you so much.

Legislator Odell: Just a couple of quick things. First, thanks to all my colleagues who were able to attend last Wednesday's midpoint presentation on the Grow Chautauqua initiative, which is becoming the empire state brands initiative. Also, on everyone's desk tonight- you'll recall a couple months ago in our June meeting that we had a resolution 165-19 where we authorized the funding for the printing of our County marketing brochure. So, on everyone's desks tonight- hot off the presses is the latest iteration and this is a great tool. A lot of thought went into it. I want to thank our IDA, County Executive Borrello, and our Planning Board for compiling this and really telling the story of us. It's going to be utilized widely not only for business recruitment and tourism, but also employee retention and employee recruitment and telling the story of what makes us in Chautauqua County a special place to live, work, laugh and learn. So, enjoy it and if you need more I've them, the IDA has them, and I'm sure Mr. County Executive has more in the office as well.

Chairman Wendel: Thank you.

Sheriff Quattrone: I just wanted to encourage everyone to come down to Kallie's Krusade. You'll have the opportunity to dunk me in the dunk tank as many times as you want to pay.

Chairman Wendel: I would like to interject really quick. I do have some good news to bring tonight. On behalf of the Western Regional Off-Track Betting Corporation I have a letter here saying, enclosed you will find funds in the amount of \$91,658. This check represents a net revenue payment to the municipality of the County from all OTB operations- Batavia Downs live racing inter-track wagering video lottery gaming- what essentially happened in 1974 was the Board of Supervisors made a decision to invest \$34,000 into the off track betting corporation. Since that time Chautauqua County has yielded \$9,401,463. So, for those of you that like to play the ponies, thank you. On the behalf of the Legislature and the County Executive, \$91,000 does go a long way in our budget. I do apologize, there was a three foot long ceremonial check that was left at my house, but the funds are coming to us.
