Regular Meeting Chautauqua County Legislature Wednesday, February 28, 2018, 6:30 p.m. Mayville, N.Y. 14757

Chairman Wendel called the meeting to order at 6:30 p.m.

Clerk Tampio called the roll and announce a quorum present. (Absent: Gould)

Legislator Niebel delivered the prayer followed by the pledge of allegiance.

1st Privilege of the Floor

My name is Bob Ruther and I'm here to speak on Local Law 1-18. I have a prepared statement if you don't mind. I don't think that anyone can question the fact that there is money to be made through energy efficiency upgrades and improvements. The real question that everyone usually asks is where do we get the money to pay for this work? Throughout the country and here in our County, one answer is the PACE program. Energize New York finance is a means to finance energy efficiency and renewable energy upgrades in commercial or nonprofit properties, or multi-family units owned by a corporation. Energize New York finance leverages the property assessed clean energy structure to provide access to capital, extended loan terms, and other benefits. Once the finance parameters have been met, PACE can provide 100% of the needed funds. Examples of PACE finance projects include office buildings, hospitals, airports, hotels, churches, and recreational centers among others. Energy efficiency measures can include any renovation or retrofitting of a building to reduce energy consumption such as windows and door replacement, lighting, insulation, air ceiling, HVAC, and similar improvements. Renewable energy projects can be solar thermal, solar (*inaudible*), wind, and aerobic digester gas or electric systems, and micro-grids among other. Research shows that leaders who make important strides in improving their counties, towns, and cities, no matter their starting point, do three things really well. They achieve smart growth, do more with less, and win support for change. Adopting Chautauqua County's PACE program is an example of smart leadership. In addition to thanking the members of this Legislature, I would like to thank Mark Odell for taking the lead on energy efficiency policy including sponsoring the PACE law. I also want to make mention of George Spanos, Director of Public Facilities, for the recent purchase of two all-electric, Class 8 yard trucks for the landfill transfer stations. We are the first municipality in the country to own this type of vehicle. The purchases were made with no additional cost to the taxpayers above what a diesel truck would have cost. These vehicles are cleaner and cost less to maintain than a diesel truck saving taxpayer dollars and I want to thank you all very much.

Clerk Tampio: Yes, I will read you a summary of that. Eight individuals were formally inducted at the Chautauqua Sports Hall of Fame 37th Annual Banquet that was held February 19, 2018 at the Lakewood Rod and Gun Club. The new honorees bought the total number of inductees to 191. The living inductees are Dick Cole, Curt Fischer, Lori Franchina, Sheilah Gulas, Fran Sirianni, Clem Worosz and Phil Young and the deceased honoree was Jim Riggs.

LOCAL LAW INTRO. 1-18 - A Local Law to Amend the Sustainable Energy Loan Program in the County of Chautauqua

Legislator Odell: My friends and esteem colleagues, this Local Law is being brought forth before us again tonight because the New York State Legislature had amended the property assessed clean energy or PACE financing laws and the County just needs to amend this local law that we unanimously passed last July. As most of you will recall and really for the benefit of our new colleagues here with us now, just for their edification, several towns and villages within the County have obtained clean energy community designation by the New York State Energy Research and Development Authority over the course of the past year. They did this by completing four of 10 high impact action items that are designed to save money, realize improved energy efficiency, foster vibrant economies and improve the environment and public health. These communities have received grant awards ranging from \$50,000 to \$100,000 as a reward for innovative leadership, stewardship and dedicated efforts. At our County level and this is what we have been working on diligently, we're working towards the same designation at the County level for clean energy communities and a \$225,000 grant award with no local cost share, by the way, that comes with it. Our counties collaborative team from the Executive and Legislative offices, the Department of Public Facilities, and the Department of Planning & Economic Development have identified our four of these 10 high impact items as being number one, a benchmarking of our billing inventories and corresponding energy requirements, which has been done by George and a team at DPF. Number two, County-wide solarized campaign which is currently underway through our Planning Department, number three, clean fleets which Mr. Ruther, if he's still here, no, he's gone, just kind of spoke on it briefly with the new electric vehicles at our transfer stations and lastly, our fourth high impact action here tonight is voting on the low cost PACE financing which is the Local Law before for this evenings action. This law allows for commercial and non-profit entities to take advantage of low interest financing through the New York State Energy Research and Development Authority for energy efficiency upgrades as well as clean energy implementation measures. Everyone's support of this important local law would be great appreciated. Thank you Mr. Chairman.

Chairman Wendel: Any other discussion or debate?

Attorney Abdella: I would just note for the record that in the findings clause, there is a reference to this law and it describes it as this "chapter", whereas everywhere else it refers to this law as actually "this law or this local law". We will view it as a typo the word "chapter" and replace it with the word "law" so it will simply state this "law" establishes a program that will allow the Energy Improvement Corporation and so forth after that.
