## Other-

Proposed Resolution- Authorizing the Sale of Curtis Street Residential Property Owned by JCC

Mr. Martello: This is a piece of property that a little while back you approved the resolution to be able to sell it for \$300,000 with eight acres. We went with \$340,000. We got no interest whatsoever. After about three or four months we met with a realtor and we said that perhaps we could go down to \$299,000. We didn't want to go to \$299,000 so we went to \$319,000 and we included additional acreage. At that time, we had an offer at \$250,000 and the board said no. We went back and we actually did go down to \$299,000 and we ended up with another offer of \$285,000. So, that is where we are at right now. We are looking to sell the

property at \$285,000 with 37 acres. As you know, we need the approval of all our sponsors. This is our first step- to ask for your approval to do so. This would return 25% of that net sale price back to the County.

Vice Chair Wilfong: Any questions?

Legislator Nazzaro: So this has been approved by the JCC- it's the recommendation of the JCC board?

Mr. Martello: Yes. This is the recommendation of our Buildings and Grounds Committee at this point in time. Our board meets in two weeks and we expect it to be passed. We will be going before Cattaraugus and the City of Jamestown to ask for their approval shortly.

Vice Chair Wilfong: Alright. Any other questions? All in favor of this resolution please say aye. Opposed?
