Legislator Niebel: First of all I'd like to thank the County negotiating team and the union for all the hard work that has gone into this settlement. I'll be voting in favor of this resolution because of the projected savings with employees transitioning to the high deductible health care plan. Health care costs are an ever increasing part of personnel costs, so to the extent that the county can reduce these costs I believe it's a good thing for the tax payers. My only concern is that a few years ago we approved a contract settlement that projected savings based on retirements for a certain department- those projections fell a little bit short, so I hope that the projected savings related to transitioning to the high deductible health care plan are more accurate. Thank you.
