Chairman Chagnon called the meeting to order at 6:34 p.m.

Clerk Tampio called the roll and announced a quorum present

Legislator Davis delivered the prayer and pledge of allegiance.

#### 1<sup>st</sup> Privilege of the Floor

Clerk Tampio: "Good evening-

As a lifelong Democrat and a resident of over 45 years, I have been appalled at the situation regarding the Chautauqua County Democratic Party Election Commissioner. I have followed this situation closely in the newspaper, and I cannot understand why you, the Democratic County Legislators, did not follow the established procedure of appointing the recommended candidate based on the wishes of the majority of the Democratic Party committee. I have not seen a single article or op-ed from any of you that explains why you have decided to nullify the wishes of the majority.

The paper reports that you plan to vote on the appointment of a different candidate at the March 24 meeting (tomorrow). Clerk Tampio: "My name is Judy Einach (I-knock). I live at 8 Beckman Avenue in Westfield, NY.

Several months ago I addressed this body to explain the process that resulted in a tiny weighted vote difference between the only 2 people who were ever voted on by the full Democratic County Committee to be put forward as our recommendation for Election Commissioner. In spite of the generally successful attempt to sway that vote, Loren Kent maintained his position as Party Secretary and was a mere 8 weighted votes shy of winning the recommendation. These 2 factors signal the strength of support for Kent in the face of an attempt to create an impossible obstacle.

Tonight I want to tell you a short story about the Loren Kent I know. Loren is a man who's dedicated his life to the Chautauqua County Democratic Party. From the time he was 8 years old helping his dad circulate petitions to the last 14 months when he's worked tirelessly to achieve a position of senior leadership in the Party, Loren has built a record of achievement. Loren led the Young Dems when he was a young man and later served, and continues to serve, as an officer of the County Committee. He has watched and learned from different Party Chairs who have taught him the difference between good and not so good leadership and what that means for the 2 Party System in Chautauqua County. Dear Ms. Tampio,

The undersigned respectfully requests that this letter be read to the full Legislature at its March 24, 2021 Meeting and placed in the record of the formal proceedings for the meeting.

The Legislature has a resolution on its Agenda seeking the appointment of the Democratic Election Commissioner. As outlined below, the undersigned oppose consideration of this resolution and or its adoption without fair and transparent consideration of Ms. Luz Torres for the position as Democratic Election Commissioner.

The sponsors of the pending resolution have failed to give consideration to the appointment of Ms. Luz Torres – and aim to gain the cooperation and cover of the full Legislature in their unfair efforts.

The pending resolution should be withdrawn or defeated because it is unfair in its treatment of Ms. Torres; the process employed by these legislators lacks transparency; and the legislators lack honor in this action.

#### Fairness

The Chautauqua County Democratic Committee put forth a highly qualified experienced person, Luz Torres, a Latina woman, to be the Democratic Election Commissioner for our County.

Initially, she was named in a Chautauqua County Legislature resolution that was adopted unanimously by the Legislature's Administrative Services Committee. The resolution was sent to the full legislature.

Before Ms. Torres's appointment could be voted on, Legislator Christine Starks withdrew the resolution without explanation.

*Ms.* Torres never got an opportunity for consideration despite her knowledge, experience, and qualifications.

Now, it appears she will never be considered.

In fairness, Ms. Torres should be given the opportunity. She deserves consideration and a vote by the full Legislature.

#### Transparency

While the five Democratic legislators initially allowed Ms. Torres to be named for appointment as the Democratic election commissioner, they withdrew her name without explanation.

While many have been told that Ms. Torres is the most qualified and that the legislators support her, the legislators have never publicly explained their decision to withdraw her name.

The legislators never publicly explained how they will proceed to name a new commissioner.

And now, the legislators have failed to publicly explain their attempt to rush an appointment other than Ms. Torres. They are now proceeding without a public announcement, without committee consideration, and by cover of a last minute addition of a resolution to the full legislature agenda with only a few days notice.

#### Courage

While it is impossible to know all of the motivations for why the Democratic legislators have acted unfairly, and without transparency regarding Ms. Torres, their utter lack of courage to appoint the most qualified person because it is the right thing to do is most damning.

Not one of the five Democratic legislators had or has the courage to say "I'm going to do the right thing".

Not one of the five Democratic legislators has or had the courage to say, "I'm supporting the best candidate who was legally presented to us".

# For shame.

May Ms. Torres not be a victim of unfairness, lack of transparency, or lack of courage by Democratic legislators.

May Ms. Luz Torres and the manner in which she has been treated not be forgotten if she falls victim to such unfairness.

We respectfully ask that the resolution be withdrawn or defeated if it is submitted to a vote.

Legislator Niebel: Was the Sheriff going to comment on this resolution?

Chairman Chagnon: I believe he was. Would you like to speak first?

Legislator Niebel: Sure. I can. First of all, I'd like to thank the Sheriff and his department for what appears to be a very comprehensive plan. A lot of time and effort went into this plan and part of the objective of the plan was to look at so called systematic racism in local police departments. Personally, I object to the term because just using the term implies that there is systemic racism and that implication should not be made before looking at the facts. The facts are; of the people who are arrested and charged by the Chautauqua County Sheriff's Office, 91% identify as white or Caucasian and according to data USA, 92% of the population of Chautauqua County is white or Caucasian. So, we have a population of 92% white, while the people being arrested and charged are 91% white; a difference of 1%, which is statistically insignificant.

There is no systemic racism in the Chautauqua County Sheriff's Department and probably none in the other policing units in Chautauqua County either. Mr. Chairman, I just wanted to clarify this particular point.

Chairman Chagnon: Thank you Mr. Niebel. Sheriff, would you like to make some comments?

Sheriff Quattrone: I sure would. First of all, thank you Mr. Chairman for giving me the time to just share a little bit of the process we went through to get public comment. Hopefully everybody knows that this is based on executive order 203 that was issued on June 12<sup>th</sup> of 2020 directing each local government (inaudible.) It has to be submitted by April 1st and certified by the County Executive. We'd like to point out that every local and county police agency had to go through this process. It was not required that any state agency would go through this. Prior to the order, as early as May 2020 the Sheriff's Office and I were working and meeting with community groups, attending some of the protests and rallies around the County to listen to the community to learn what their needs and their wants were. We also have collaborated with other police agencies in Chautauqua County. We've worked together to convene our (inaudible) groups and listen to them either through personal meetings or Zoom and Facebook Live meetings. We had a county-wide survey, conducted seven Facebook Live Zoom meetings with the stakeholders from the various municipalities and police agencies. We completed the draft report and submitted a media release announcing that we would be doing an additional five Zoom meetings- Facebook Live meetings to give the opportunity for the community to have input and at the recommendation at our County Attorney's Office, we also placed the draft report in all attachments in every public library in the County. We have received very few comments back. (Inaudible) we had one negative comment and that was to get rid of all police, so that wasn't specifically for the Sheriff's Office, but to all law enforcement. Many of the comments were saying that they were pleased with the Sheriff's Office as well as other Police Departments in the County. There were several comments about rather than having criminal justice reform that we needed to have criminal reform and to eliminate the bail reform regulations. Overall, I'd like to say it's a good process- something I've felt we've been doing very well and as is many other police agencies in the County and this just helped us to be more specific and intentional with getting that input from the community.

Chairman Chagnon: Thank you for your comments.

Sheriff Quattrone: Thank you.

Legislator Rankin: I'd actually like to follow up with that and say that we are so blessed to have Sheriff Quattrone who last summer, when everything was so difficult whatever the challenges were, that Sheriff Quattrone showed up at everything he could- at the protests, the rallies to show people that he was interested, he wanted to hear their concerns, he was there and represented us so well. I think we are really blessed to have you and I really appreciate everything you've done to represent law enforcement in situations that have been very difficult. You've been willing to listen and hear what people have to say and make adjustments based on that and with great respect I want to personally thank you for that.

Chairman Chagnon: Thank you Legislator Rankin. Are there any other comments? Legislator Ward.

Legislator Ward: Thank you. I would like to add my thanks to the Sheriff and all the folks that work on this initiative because no matter how we might perceive the issues in this county, you, by your actions and by your intent understand that there are some problems somewhere and that proactive action on your part and on our parts are going to be the *(inaudible)* that keep us ahead of the curve if indeed that is the case, so I really appreciate this kind of proactive work. It's what needs to be done in more places around this county and once again, Chautauqua County sort of leads the way, so thank you.

Clerk Tampio: Right. Under decrease appropriation accounts, account number EWN.8310.4 contractual water district the original amount is \$562 and it should be changed to \$582, which also changes the balance by the same amount, so instead of \$736,453 it is now \$736,473.

Likewise, increase appropriation accounts EWN.8310.8 employee benefits water district in the amount of \$562 is amended to \$582 and that also changes the total of that column which is

\$594,962, where the previous amount was \$594,942. Those were the recommended changes provided by Budget Director Dennison.

Chairman Chagnon: O.K., thank you.

Chairman Chagnon: Then lets have a discussion on the motion to amend resolution 80-21. Are there any comments, questions, discussion? Hearing none and seeing none, all those in favor of the motion to amend please say aye. Opposed?

Unanimously Carried to Amend Resolution 80-21

Chairman Chagnon: Now, for discussion, questions, comments on resolution 80-21 as amended.

Legislator Ward: Thank you. Once again I'm having real trouble wrapping my head around this and I've talked to my colleagues about this. I'm grateful, especially to my democratic colleagues who are on the legislature who are sort of willing to fall on the sword here to solve a problem that in my heart seems like it's not up to us to solve. I mean, it is this body's task to ratify a cogent candidate for this position, but I don't think that we've gotten that. I think that we are still seeing a fracture in the Democratic Party and we are being asked to arbitrate that. I admire my democratic colleagues willingness to do this and respect your decision, I'm just stil confused why this body is arbitrating this and now it's going to go to court and I'm afraid that it's going to cost us even more money. I think there are too many questions and I would move to table this resolution in hopes that we can get it back to the Democratic Party to figure out and not leave us as sort of the *(inaudible.)* 

Chairman Chagnon: O.K., we have a motion to table by Legislator Ward. Do we have a second?

Legislator Hemmer: Yes, Chairman Chagnon I'd like to second that motion. I feel the same way. As we've heard from the letters coming into the Legislature, this is not a question that has been adequately considered by the Democratic committee and the democrat legislators and I do not feel like it's the position of the Legislature to make a decision for them. They need to take this upon themselves and get it straight. Chairman Chagnon: O.K., we have a motion and a second. There is no discussion on the motion, so all in favor of tabling resolution 80-21 as amended please say aye. Opposed?

# Motion to Table Resolution 80-21 Failed – 2 Yes; 17 No (Hemmer and Ward voting Yes)

Chairman Chagnon: Motion to table is defeated. We will proceed with discussion of resolution 80-21 as amended.

Legislator Scudder: Thank you. I've prepared a brief statement that I'd like to read. Tonight, I will not be voting in support of resolution 80-21. My concern with this resolution is that it does not seem to have the full support of both the Democratic County Committee and the Democrat County Legislators. In my 12 years as a legislator I have voted to appoint both the Democrat and Republican Commissioners of Elections to the respective offices. The votes were always unanimous and no politics were influential to my vote. This year has been a different story. We have pulled a resolution after a committee's favorable vote. We have had *(inaudible)* not presented to the legislature for this position. Let me be clear; this is not a no vote for Loren Kent. This is no vote for the democrats of this Legislature and this is not a no vote against the Democratic County Committee. This is a vote of no for a resolution that does not have the support as I have experienced in the past. I am not confident in this resolution and I also have a concern that if the outcome goes one way or the other the tax payers of Chautauqua County will be left paying for legal actions. Thank you.

# Chairman Chagnon: Thank you. Other comments?

Legislator Nazzaro: Thank you. As Democratic Minority Leader, I appreciate all the legislators reviewing this resolution and obviously you are to vote whatever way you so desire, but I do want to make one comment. The Democratic Caucus is united. We stand behind Loren Kent and because of the temporary restraining order and pending litigation, this case will be heard in the Supreme Court on April 26<sup>th</sup>, just a month away. Once that is heard, the Democratic Caucus will be making a public statement outlining all of our rational reasoning for bringing this resolution forward. At this time, I encourage my colleagues to vote for this and let the courts decide in April. Again, we'll be releasing a public statement at a later date. Thank you so much.

Chairman Chagnon: Thank you. Other comments or questions?

Legislator Rankin: Thank you Legislator Nazzaro. I appreciate your comments because I will be voting in favor of this out of respect and the highest regard for my democratic colleagues who have had to work so well and I just appreciate everything we do together as a team and my feeling is that if you are behind this, I will vote in favor of this because you are behind this. So, thank you all of you for everything you do and that's why I'm going to vote is in favor of what you believe. Thank you.

Chairman Chagnon: Thank you. Other comments?

Legislator Ward: Thank you, again. Thank you Chairman Nazzaro. I do appreciate all the hard work you've done and I do want to echo Legislator Scudder's comments that when I vote no against this it

is it not a vote for or against these candidates that have been put forth, it is simply a vote against this process that seems to be fatally flawed.

Legislator Hemmer: Mr. Chairman? I agree with Legislator Scudder and Legislator Ward. This process is obviously a flawed process. I'm not voting against the sitting democrat legislators, I'm voting against the process that took place here. I do not believe that New York State Election Law has been followed and therefore I'm going to vote no. Thank you.

Chairman Chagnon: Thank you. Other comments? Discussion? Hearing none and seeing none, will the Clerk please call the roll?

# **PRIVILEGE OF THE FLOOR**

Chairman Chagnon: Kathy, are there any communications received for the second privilege of the floor?

Clerk Tampio: Yes there are, Mr. Chairman. I have three of them. This is submitted by Karen Engstrom of Mayville, New York.

*"Two points to consider:* 

• Point 1 -- Niagara County legislators propose a solar recycling mandate bill. The bill, proposed by Niagara County Legislator Dave Godfrey, proposes a local law that requires solar panel manufacturers to finance the recovery and recycling of any of their solar panels installed in Niagara County.

Legislator Godfrey said, "We are doing everything we can to battle against Gov. Cuomo's efforts to strip away local decision-making on where these green energy projects can be located in Niagara County. But we need to be prepared to protect our community from becoming a depository for spent solar panels that contain hazardous waste even for solar projects that enjoy the support from local residents."

"The lack of action by New York State is the reason we are being proactive in passing a local law for Niagara County," Godfrey said. A similar plan was adopted by the state of Washington. Godfrey said. "There are solar projects being proposed all across Niagara County with zero plan for recycling. This law will stop that. We will make every solar developer and manufacturer acknowledge this financial responsibility on their end and, if that makes them decide not to come here, well we're OK with that, too."

• Point 2 -- Forbes Magazine, recently stated utility solar at this latitude

- 42 degrees north – falls below the "economically viable threshold".

Forbes author Robert Bryce explains the energy industry standard that measures energy efficiency is called "Energy Returned on Energy Invested " (ERoEI).

The energy expended to manufacture, transport, install and decommission utility scale solar EXCEDES the amount of energy utility solar can produce in the lifetime of a solar project in New York State.

Thank You, Karen Engstrom, Mayville New York:

Clerk Tampio: This comes from Joni Riggle of Sinclairville, New York. "Dear Legislators,

I fully support Karen Engstrom's letter proposing the adoption of a solar module recycling mandate. Of significant concern, NYSERDA admits there is still no viable recycling for end- of- life solar panels. I received the following email from NYSERDA/NY SUN regarding this.

There are a couple of items in your question that we need to address. The first is the question of recycling solar modules (panels). Because of the long useful life, there is not currently a large enough waste stream to consider recycling a viable option today. The waste stream is not expected to occur for another 20 to 25 years. NYS DEC is already considering what that will look like and what measures will need to be in place to take care of that. However, without a waste stream, recycling will remain in the planning stage. That does not mean that we should not plan for the eventual decommissioning of these systems. NYSERDA as part of the NY-Sun program provides technical assistance and guidance to local governments, the "Guidebook" has a specific chapter relating to decommissioning.

Thank you for your thoughtful consideration in this matter!"

Clerk Tampio: I have one more. This comes from Robert and Katherine Galbraith of Ripley/Westfield.

"The Politics Are Way Ahead of the Science, or New York State Energy Policy, Texas Style The irony is inescapable. ConnectGen, a Texas LLC, is proposing to develop 1,500-2,000 acres of Agricultural and Forested land for the South Ripley Solar Project. Last month, Texas was hit with massive power outages precipitated by an unrealistic energy policy that was too dependent on intermittent power generation from wind and solar. New York State is recklessly heading down the same "Green Energy" path as Texas, where a faulty renewable energy policy added up to power outages and rolling blackouts. Texas suffered severe, sometimes tragic, results. Considering this, it is appropriate for our elected officials to reconsider New York's energy plans. Given the recent revelations of Governor Cuomo's actions, it brings into question his policies on renewable energy. Let's look at the facts: • Our state, our businesses, our homes, our country, cannot rely on intermittent power. We need a steady, sustained source of power -

which we currently have with our hydroelectric (70%) and nuclear (no CO2 emissions) power sources. • New York State, and Chautauqua County in particular, have the worst solar insolation *in the country.* • *The only reason the state is being overrun by solar developers is the Federal* and New York state overly generous tax credits, subsidies, and advanced depreciation, "Green *Energy*" credits, enhanced electricity rates, and local tax abatements. These actions have nothing to do with good environmental stewardship. • The South Ripley Solar Project capacity is 270 megawatts, but given the efficiency of the panels of 14%, real output will be in the area of 34 megawatts, while sacrificing 1,500-2,000 acres of agricultural and forested land. • Solar panels are typically manufactured in China, and are composed of rare earth elements and other materials known to be toxic. They are also known to be coated with an anti-glare compound *called perfluoroalkyl (PFAS) substances which is toxic and cannot be broken down.* • *Currently* there is no way to recycle solar panels. Once they reach their life expectancy, they will be tossed into a landfill. • Decommissioning plans and funding remain a major concern, the possibility being the taxpavers are left holding the bag to decommission these projects. • The newly formed State Office of Renewable Energy Siting, or ORES, has just issued regulations called Section 94-*C*, which overhauls the state's large scale renewable siting processes. This fast tracks all NY State's renewable energy projects. 94-C moves these projects to a centralized, closed, decision making process, bypassing local government input. • Our rights as citizens have been severely curtailed by this new policy. • Our counties and our towns are the last line of defense against the onslaught of these solar developers. We still have options to control the outcome and protect ourselves and the environment by passing sensible, fair, and comprehensive zoning laws. Ripley *currently has their draft law out for comment, which will hopefully be adopted soon.* • *We request* that the Chautauqua County Industrial Development Agency (CCIDA), carefully consider their positions on Payment In Lieu of Taxes (PILOT) on proposed solar and wind projects. Consider, not only the financial ramifications, but also the impact these projects will have on the health and safety of our communities and our environment. Without any checks and balances provided on the county and local levels, the solar industry will proliferate throughout Chautauqua County and our neighboring counties, turning our green farmland and forests into wastelands. • We urge the County Legislature to pass a No-PILOT resolution and send it to the Chautauqua County IDA. We cannot sit by and watch our beautiful farmland, animal habitats, and verdant forests destroyed in the name of "Green Energy.
