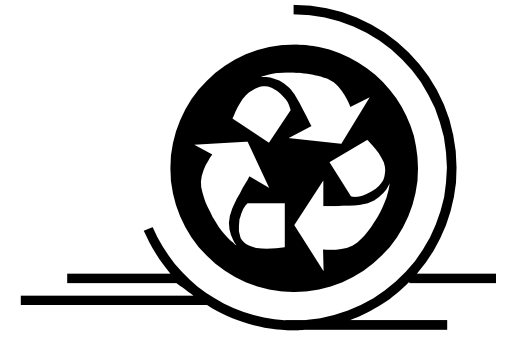

# Chautauqua County Recycling

## Glass: Jars & Bottles

Rinse clean & separate: clear – colored beverage and food containers only. NO ceramics, light bulbs, ovenware or window glass.

## Plastics

Rinse and clean beverage, food, detergent, mouthwash and shampoo containers only. NO automotive fluids containers, bags or K-cups.

## Metal Containers Aluminum/Tin/Steel

Rinse clean cans, foil, lids, trays, etc. NO bags or spray cans.

## Scrap Metal

Aluminum, Brass, Copper, Steel, Cast Iron, Machinery, Home Appliances, Wire, Pipe, Etc.

## Cardboard

Corrugated Cardboard Boxes, Paper Bags, Paper Egg Cartons, Cereal Boxes, Toilet Paper & Paper Towel Tubes & Beverage Case Boxes.  
NOT ACCEPTED: Waxed, plastic coated, plastic or foam packaging or food-contaminated materials.

## Paper

Newspapers, Magazines, Catalogs, Office Papers, Greeting Cards, Books and Notebooks without covers or bindings. NO padded envelopes, pet food bag or bags of shredded paper.

## Tires

FEE CHARGED-See other side, or Return them to retailer

## Electronics & Small Appliances

Electronics and small appliances accepted free of charge for recycling. Examples:

- Computers and accessories (desktops, laptops, tablet PCs, e-readers, Servers, Keyboards, mice.
- Facsimile Machines, printers, scanners and cables
- VCRs, DVRs, DVD Players
- Cable or Satellite Receivers
- Electronic or Video Game Consoles
- Printers, printer cartridges, etc.

**Exception** – There is a fee, for all televisions and computer monitors (see other side).

Per New York State Law, the manufacturers of new or old equipment are required to accept your old equipment for recycling at no charge. For more information, visit:

Electronics & small appliances are Not Accepted at Ellery Transfer Station.

## Batteries

Return rechargeable batteries to any retailer that sells rechargeable batteries. Put non-rechargeable batteries in trash.

NOT ACCEPTABLE: AUTOMOBILE LEAD ACID BATTERIES: Retailers and Distributors shall accept your used car batteries.

## Motor Oil- NOT ACCEPTED

Please return used motor oil at your local service station or auto-parts store.

## Household Hazardous Waste Drop-Off Events

At the events listed below, county residents may drop-off, free-of-charge, small quantities of hazardous materials used in and around the home, **that should be kept out of the normal garbage** sent to the landfill and transfer stations. A completed registration form is required at the time of drop off. At home: Print and complete the registration form, listing all materials being dropped-off. Submit the completed form upon entering one of the Household Hazardous Waste Collection sites.

## Freon Containing Items

ACCEPTABLE: Refrigerators, Freezers (doors removed), Air Conditioners, Dehumidifiers & other items containing Freon. There is a per item charge for safe Freon removal. See other side for Freon Fee.

**NOTE: No charge if Freon removed by a certified Removal Technician their company letterhead including make and serial number of Freon unit.**
