Privilege of the Floor

Hi my name is Ida Golden and I'm a Chautauqua County resident and I'm here today because last night I watched the health committee meeting and I was pretty disturbed about what I heard. So I'm here speaking about proposal #11 on your agenda, Authorize Acceptance of Aging and Disability Vaccination Collaborative Funding for Chautauqua County. Some of you may not know about this already because maybe it's the first time you're hearing about it so this is the \$286,000 grant. It will incentivize COVID and vax flu shots against minority populations of all ages. 2,500 shots is the goal. Coercing people with \$25 gift cards to local businesses. I had hope that the health committee body would have recognized this resolution for its ethical void. The committee acknowledged that people can get these shots for free if they wanted them and \$25 may be the push needed for low income people to do the right thing. One legislator remarked, whatever works. Using coercion targeting the needs of individuals is a total disregard for their dignity. The health networks will be targeting towards disabled and minority populations. These are known low income groups. They mention that Chautauqua (inaudible) believes coercion would tip the scales for this segment of the population to get vaxed. Besides the ethical aspects of this resolution, it's a horrible waste of money. We are a Nation with 33 trillion dollars in debt. By voting for this resolution such as this one, you will be contributing to that debt. If people want those shots, they would have gotten them and it is past time, this spending spree ends. I don't know how it's legal to coerce vulnerable individuals and the other issue is how are they determining where these gift cards come from and what safeguards will be in place against kickbacks and money laundering? And that's what I have to say today. I hope

that you consider this and by not voting this resolution through. The spending has to end, it just needs to end. Thank you.
