Glass: Jars & Bottles

Rinsed and clean clear & colored beverage and food containers only. NO ceramics, light bulbs, ovenware, dishes, drinking glasses or window glass.

Plastics

Rinsed and clean beverage, food, detergent, mouthwash and shampoo containers only. NO automotive fluid containers, bags of any kind or K-cups.

Metal Containers Aluminum/Tin/Steel

Rinse clean cans, foil, lids, trays, etc. NO bags or spray cans.

Scrap Metal

Aluminum, Brass, Copper, Steel, Cast Iron, Machinery, Home Appliances, Wire, Pipe, Etc.

Cardboard

Corrugated Cardboard Boxes, Paper Bags, Paper Egg Cartons, Cereal Boxes, Toilet Paper & Paper Towel Tubes & Beverage Case Boxes.

NO Waxed, plastic coated, plastic or foam packaging or food-contaminated materials.

Paper

Newspapers, Magazines, Catalogs, Office Papers, Greeting Cards, Books and Notebooks without covers or bindings. NO padded envelopes, pet food bag or bags of shredded paper.

Tires

FEE CHARGED: See other side.

Electronics & Small Appliances

Electronics and small appliances accepted free of charge for recycling.

Examples:

- Computers and accessories (desktop, laptop, tablets, e-readers, servers, keyboards, mice)
- Facsimile Machines, printers, scanners and cables
- VCRs, DVRs, DVD Players
- Cable or Satellite Receivers
- Electronic or Video Game Consoles
- Printers, printer cartridges, etc.
- TV's, Computer Monitors

NO lightbulbs or fluorescent tubes

Batteries

Return rechargeable batteries to any retailer that sells rechargeable batteries. Put non-rechargeable batteries in trash.

Motor Oil - **NOT ACCEPTED**

Please return used motor oil at your local service station or auto-parts store.

Household Hazardous Waste Drop-Off Events

At the events: County residents may drop-off small quantities of hazardous materials used in and around the home free of charge. A completed registration form is required at the time of drop off.

At home: Print and complete the registration form, listing all materials being dropped-off. Submit the completed form upon entering one of the Household Hazardous Waste Collection sites.

Freon Containing Items

ACCEPTABLE: Refrigerators, Freezers (doors removed), Air Conditioners, Dehumidifiers & other items containing Freon. There is a per item charge for safe Freon removal. See other side for Freon Fee.

NOTE: No charge if Freon removal is verified by a certified Removal Technician's signature on company letterhead, including make and serial number of Freon unit
