This is a much better project and far more affordable so I commend them, so thank you.

Hi, I'm Jim Wehrfritz, 4433 Lakeside Drive, Bemus Point and I'm President of the Chautauqua Lake Property Owners Association, the CLPOA. The CLPOA is a 501c3 non-profit supporting the interests of property and business owners and lake users in and near to Chautaugua Lake. I wish to thank Legislators Chagnon, Proctor, Heiser, Gustafson, Vanstrom, Penhollow, and Scudder for sponsoring, the Planning & Economic Development Committee for endorsing, and the Legislature for approving Resolution No. 290-24 last month. A letter to Governor Hochul "Requesting Governor Hochul Delay the Implementation of the New Proposed NYSDEC Wetland Regulations Until All Issues Can Be Fully Understood and Addressed" followed. The Chautauqua Lake and Watershed Management Alliance on whose board County Executive Wendell, Legislature Chairman Chagnon, and Legislator Proctor sit, approved a resolution with identical wording last week. They are in good company. Our Congressman, our State Senator, Assemblyman, and his recently elected replacement, all but one lakeside municipality boards, the CLPOA and the Chautauqua Lake Partnership, have publicly opposed the flawed, incomplete, and harmful regulations. Only the Chautauqua Conewango Consortium and the Chautauqua Watershed Conservancy support them. The Town of Chautauqua and the Chautauqua Lake Association have remained silent and are assumed to be supportive as well. We hope the Governor will act prior to the regulations' planned implementation on January 1, 2025. In the meantime we'll be gathering resources and preparing for litigation to protect property and business owner and lake user interests when the DEC begins enforcement. Our request to you: attend "Wetlands" Public Meeting #6, Saturday, November 23, 9:30-11:00 am at The Lawson Center in Bemus Point, to learn more about how this will occur, what's being done about it, and how you can assist. We won't put you on the spot if your there. Changing gears and on a much more hopeful note. Many Chautauqua Lake studies have been completed over the last 50 years. In fact, "Chautauqua Lake studies", typically lacking actionable recommendations, with recommendations "watered down" to gain consensus, or with recommendations not fully implemented, are a recurring disappointment among year round and seasonal residents and lake users. However, we now have two excellent opportunities which could result in significant lake improvement and facilitate more well organized and appropriate County involvement, improving the lake and maintaining the County tax base to the benefit of all in the County. First is the recently announced US Army Corps of Engineers "Chautauqua Lake Aquatic Ecosystem" Restoration Study". The Corps' project experience and approach, with a clear focus on actionable recommendations, differentiates it from the many other studies which have been and are being conducted on the Lake. We're guardedly optimistic. As such we see this Corps study as truly the "Last and Best Hope for Chautauqua Lake", a study which must be effectively supported by the County. In last month's Legislature meeting and in a subsequent letter to the Chairperson and

County Executive we identified five requests of the County necessary for a successful core of engineers result. We're awaiting responses to our requests to meet with Mr. Chagnon and Mr. Wendell to discuss. In support of one of our requests, the CLPOA developed and provided the Corps a list of 65 previous Chautauqua Lake studies. Second, at the urging of the NYSDEC and the Chautauqua Lake Partnership, the Chautauqua Lake and Watershed Management Alliance, in early 2023, funded the development of the "Long Term Management Plan for Submersed Aquatic Vegetation at Chautauqua Lake." The was completed and issued by the North Carolina State University Aquatic Plant Management Team and Dr. Rob Richardson highly-respected leaders in lake management, in June 2024. It is professional, complete, with a balanced science and technology-base, and of a quality never seen before on our Lake. Credit for the Plan's concept and proposal goes to the Chautauqua Lake Partnership and to the Alliance which funded it. The CLPOA claims no credit for it but is committed to its use on behalf of property and business owners and lake users. Our request to you: familiarize yourself with the Plan on the Chautauqua Lake Partnership or Alliance websites, consider its adoption, and encourage the Alliance and the nine lakeside municipalities to do the same. Thank you for your consideration.

As a fourth generation resident of Chautauqua County and native, I would like to express my thanks for the beauty and the quality of life that we share here and the bounty that is provided by our County for all of us and I'd also like to share with you some information that will hopefully will make an effort to keep it just this way. Our region is again being targeted by industrial solar, industrial wind and industrial battery energy storage systems. BESS. There are more than 100 battery energy storage systems in the State pipeline targeting our area. BESS is dangerous, it is wasteful. The 100 megawatt BESS that is already planned and announced will cost us 100 million dollar for 100 megawatts. 100 million dollars for a battery energy storage system that will last 2-4 hours. The cost in tax dollars and rate increases will force more business and residents to flee our region. The materials to build BESS operations and solar developments cause huge waste and destruction in the source countries far away from us and become a disposal nightmare here. We may say its clean here but it is not clean where it comes from. The materials and the manufacturing of these are unacceptable. The rationale for destroying the forests, the agricultural land, the tourism related based economy that we all enjoy, the rationale for this or the reasoning that is given is that CO2 is a poison. But this rationale does not exist. There is still only .04% less than 1% of the atmosphere is carbon dioxide. .04%. Life on earth has flourished when there was hundreds of times more CO2 in the atmosphere. The CO2 cycles. It does not accumulate, it cycles through the oceans, the soil and the plants, that use it as food to produce everything that is life on earth. It is vital to life on earth so it cannot be used to justify these destructive aspects that are being forced upon us. New York's electricity rate at 28 cents per kilowatt hour is one of the highest in the Country. There is very little transmission that could even accommodate any increases in production. The wasteful, harmful, battery energy storage systems can be stopped. The governing can place a moratorium on all BESS development through moratoriums, pilot, denials and the local officials can prevent this State from turning our region into an energy colony, which is what it has becoming, an energy colony for down State, thank you.
