RESOLVED, that (a) the Board of Education (the "Board") of the Fredonia Central School District, Chautaugua County, New York (the "District") is hereby authorized to undertake the first component of a proposed three-part capital improvements project (the "Proposition No. 1 Project") consisting of the reconstruction, rehabilitation and renovation of, and the construction of improvements and upgrades to, various District buildings and facilities and the sites thereof to implement various health, safety, accessibility and Code compliance measures and various other measures that are included and described in (but are not to be limited by) the Proposition No. 1 Project Plan that was referred to in the public notice of the vote on this Proposition No. 1, and to expend therefor an amount not to exceed \$22,100,000; (b) the Board is hereby authorized to partially finance the project by expending or applying, during the current fiscal year (1) the entire remaining balance (which stood at approximately \$150,000 as of September 30, 2024), plus any remaining interest earned, from the District's Capital Reserve Fund, 2016), and then to terminate such fund and (2) \$150,000 from the District's Capital Reserve Fund, 2021; (c) a tax is hereby voted in an amount not to exceed \$21,800,000 to finance the balance of the estimated maximum cost of the Proposition No. 1 Project, such tax to be levied and collected in installments in such years and in such amounts as shall be determined by the Board; (d) in anticipation of such tax, obligations of the District are hereby authorized to be issued in an aggregate principal amount of not to exceed \$21,800,000, and a tax is hereby voted to pay the interest on such obligations as the same shall become due and payable; and (e) New York State Building Aid funds expected to be received by the District are anticipated to offset a substantial part of such costs, and such funds, to the extent received, shall be applied to offset and reduce the amount of taxes herein authorized to be levied.



(c) in anticipation of such tax, obligations of the District are hereby authorized to be issued in an aggregate principal amount of not to exceed \$19,600,000, and a tax is hereby voted to pay the interest on such obligations as the same shall become due and payable; and (d) New York State Building Aid funds expected to be received by the District are anticipated to offset a substantial part of such costs, and such funds, to the extent received, shall be applied to offset and reduce the amount of taxes herein authorized to be levied.
