**Proposition No. 1**  
**2025-2026 Budget**

Shall the following resolution be adopted?  
RESOLVED, that the budget for the Frewsburg Central School District (the “District”) for the fiscal year commencing July 1, 2025 and ending June 30, 2026, as presented by the Board of Education, is hereby approved and adopted, and the required funds therefor are hereby appropriated and the necessary real property taxes shall be raised by a tax on the taxable property in the District to be levied and collected as required by law.

**Proposition No. 2**  
**Purchase and Financing of Buses**

Shall the following resolutions be adopted?  
RESOLVED, that the Board of Education of the Frewsburg Central School District, Cattaraugus and Chautauqua Counties, New York, (the “District”), is hereby authorized to purchase school buses and similar vehicles (and related equipment) for use in the transportation program of the District, at an estimated maximum cost of \$380,000, and to expend therefor an aggregate sum not to exceed \$380,000; and be it further  
RESOLVED, that the sum of \$380,000 (which may include certain up-front financing costs), plus an amount for interest thereon, may be funded by the levy of a tax upon the taxable property of the District and collected in annual installments as provided by Section 416 of the Education Law; and be it further  
RESOLVED, that in anticipation of such tax, bonds or other obligations (including, without limitation, serial bonds, statutory installment bonds, bond anticipation notes and/or obligations arising under leases, lease/purchase contracts or installment purchase contracts having a term of not more than five years) of the District shall be issued or entered into in accordance with applicable provisions of New York State law; and be it further  
RESOLVED, that New York State Transportation Aid funds expected to be received by the District are anticipated to offset a portion of such costs, and such funds, to the extent received, shall be applied to offset and reduce the amount of taxes herein authorized to be levied.
