PUBLIC HEARING ON CHAUTAUQUA COUNTY  
TENTATIVE BUDGET

NOTICE IS HEREBY GIVEN, That the Legislature of the County of Chautauqua will meet in the Legislative Chambers, Gerace Office Building, Mayville, N.Y. at 6:30 PM on Wednesday, October 27, 2021 for the purpose of holding a public hearing on the tentative budget of Chautauqua County for the fiscal year beginning January 1, 2022. Citizens attending shall have the right to provide written and oral comments and ask questions concerning the entire budget. The total tentative budget is \$278,927,364. The tentative budget is funded by \$68,139,034 property tax; \$79,394,465 sales tax and the balance from state and federal aid, department income, fund balances and reserves.

FURTHER NOTICE IS GIVEN, That copies of said Tentative Budget are available at the office of the Clerk of the Legislature at Mayville, N.Y. where they may be inspected or procured by any interested person during business hours. Pursuant to Section 359 of the County Law, maximum salaries that may be fixed and payable during said fiscal year to members of said Legislature and to the Chairman thereof respectively are hereby specified as follows: 19 members of the Chautauqua County Legislature - \$9,000 – 1 Chmn. of Legislature - \$9,000 plus \$8,000. The following positions are additionally compensated no more than the amounts indicated, over and above the basic legislator's salary. 1 Majority Leader - \$1,000; 1 Minority Leader - \$1,000; 1 Asst. Majority Leader - \$500; 1 Asst. Minority Leader - \$500; Each Committee Chairman - \$1,000; Ranking Members - \$250. No Legislator shall be compensated for more than one of the above-mentioned positions.

PLEASE TAKE NOTICE, the public may participate in the public hearing by appearing in person at the Legislature Chambers during the 6:30 PM public hearing to make a live statement. The hearing facility is handicapped accessible. The meeting is open to the public and subject to all current COVID-19 guidelines.
