Minimum Qualifications: Applicants must be in possession of a high school or high school equivalency diploma and **EITHER** have completed a two-year post-secondary program for heavy diesel engine equipment technician; **OR** completed a two-year post-secondary program for Automotive Technology PLUS have one (1) year of experience as a skilled heavy equipment automotive mechanic, which shall have involved repair and maintenance of heavy-duty gasoline or diesel engine automotive equipment used in construction, farming or commercial fleet operations; **OR** two (2) years of experience aforementioned.

Please note: Experience must be at the skilled mechanic level. Performing minor repairs and maintenance incidental to operating heavy automotive equipment is not considered qualifying experience.

Additional Requirements: Applicants must possess a valid New York State Class D Operator's License. Possession of a valid NYS Class B CDL and air brakes certification within six (6) months after appointment, or before completion of probationary period whichever is sooner, and during service in this class will be required. Must have own tools at time of appointment and during service in this class. Requires NYS certification as a motor vehicle inspector and certification per 42 U.S.C. Section 7671h for servicing of motor vehicle air conditioners within 12 months of appointment, and during service in this class.
