

You have a right to a replacement ballot. If you make a mistake or want to change your vote, call the board of elections at (716) 753-4580 for instructions on how to obtain a new ballot. The number of choices is listed for each contest. Do not mark the ballot for more candidates than allowed. If you do, your vote in that contest will not count.
