<div>Proposition #1</div> <div>RESOLVED, that the basic budget for the Silver Creek Central School District, Chautauqua County, New York (the “District”), for the fiscal year commencing July 1, 2025 and ending June 30, 2026, as presented by the Board of Education, is hereby approved and adopted in the amount of \$32,177,552, and the required funds therefor are hereby appropriated and the necessary real property taxes required shall be raised by a tax on the taxable property in the District to be levied and collected as required by law.</div> <div><div>Yes</div><div>No</div><div><input type="radio"/></div><div><input type="radio"/></div></div>	<div>Proposition #2</div> <div>RESOLVED, that the Board of Education (the “Board”) of the Silver Creek Central School District (the “District”) be, and it hereby is, authorized to (A) purchase, for use in the District’s Transportation and Building and Grounds Departments, three 66-passenger diesel school buses (and related equipment) at an aggregate estimated maximum cost of \$537,000, two 4-door District vehicles at an aggregate cost of \$82,000, and one plow truck at a cost of \$65,000, the estimated aggregate cost for all of the above vehicles being \$684,000, (B) expend or apply toward the purchase, during the current fiscal year of the District: (1) the entire remaining balance (which stood at approximately \$347,243.08 as of March 13, 2025), plus any additional interest earned, from the District’s voter-approved 2015 Capital Reserve for Vehicles (with such fund then to be terminated) and (2) \$336,756.92 from the District’s 2022 Capital Reserve for Vehicles, thereby eliminating the District’s need to borrow money or issue obligations to finance such acquisition; and BE IT FURTHER RESOLVED, that this authorization for the use of reserve fund monies that are already on hand shall have no effect on the tax rate for the 2025-2026 school year.</div> <div><div>Yes</div><div>No</div><div><input type="radio"/></div><div><input type="radio"/></div></div>
<div>Proposition #3</div> <div>RESOLVED, that the Board of Education (the “Board”) of the Silver Creek Central School District, Chautauqua County, New York (the “District”) be, and it hereby is, authorized to dissolve the Capital Reserve created in 2017 and use the remaining balance to pay for balances owed for bonded indebtedness in the 2025-2026 school year, thereby avoiding the need for the District to use general fund monies; and BE IT FURTHER RESOLVED, that this authorization for the use of reserve fund monies that are already on hand shall have no effect on the tax rate for the 2025-2026 school year.</div> <div><div>Yes</div><div>No</div><div><input type="radio"/></div><div><input type="radio"/></div></div>	<div>Proposition #4</div> <div>RESOLVED, that the Board of Education of the Silver Creek Central School District is hereby authorized to levy and collect taxes annually, separate and apart from the annual District Budget, in the amount of \$127,110 which shall be paid to the Anderson Lee Library for the support and maintenance of that library; with this appropriated amount to be the annual appropriation until thereafter modified by a future vote of the electors of the District.</div> <div><div>Yes</div><div>No</div><div><input type="radio"/></div><div><input type="radio"/></div></div>
