<u>APPLICATION FEE</u>: A fee of \$15.00 is required for each separately numbered examination for which you apply. The required fee must accompany your application. Send check or money order payable to the Director of Finance and write the examination number and title on your check or money order. We cannot accept cash. No refund will be made on approved applications. You are urged to review the examination announcement carefully, to compare your qualifications with the requirements for admission, and to file only for those examinations for which you are clearly qualified.

<u>APPLICATION FEE WAIVER</u>: A waiver of application fee will be allowed if you are unemployed and primarily responsible for the support of a household. In addition, a waiver of application fee will be allowed if you are determined eligible for Medicaid, or receiving Supplemental Security Income payments, or Public Assistance (Temporary Assistance for Needy Families/Family Assistance or Safety Net Assistance) or are certified Job Training Partnership Act/Workforce Investment Act eligible through a State or local social service agency. All claims for application fee waiver are subject to verification. <u>APPLICATION FORM</u>: Your application for this test is part of the examination process. Applications must be completely filled out, with all pertinent information stated. Vagueness or ambiguity will <u>not</u> be interpreted in your favor. We do <u>not</u> refer to other applications on file for additional information. Applications that do not show training and/or experience to meet minimum qualifications may be disapproved.

VACANCIES: At present one (1) vacancy exists in the Chautauqua County Department of Public Facilities.

<u>DUTIES</u>: A Storekeeper III performs first line supervisory level work involving responsibility for procedures, methods, cost containment and the supervision of a small clerical staff in the operation and maintenance of a storeroom function for a large public works department. Work is performed under the general direction of a supervising mechanic with wide leeway granted for the exercise of independent judgment in determining methods and priorities for the unit. Supervision is exercised over several Storekeeper positions of lesser rank. Does related work as required.

MINIMUM QUALIFICATIONS: Two (2) years of permanent competitive class status as Storekeeper II or four (4) years of permanent competitive class status as Storekeeper I.

ADDITIONAL REQUIREMENTS: Possession of a valid New York State class D driver's license at time of appointment and during service in this classification.

IDENTIFICATION (ID) REQUIREMENT: Examination candidates will need to present a valid photo ID upon arrival at the examination site for purposes of examination security and candidate identification.

SUBJECTS OF EXAMINATION: Written test will test for knowledge, skills, and/or abilities in such areas as:

- <u>Understanding and interpreting written material</u> These questions test for the ability to understand and interpret written material. You will be presented with brief reading passages and will be asked questions about the passages. You should base your answers to the questions only on what is presented in the passages and not on what you may happen to know about the topic.
- <u>Automotive terminology and identification of automotive parts</u> These questions will test for, but will not necessarily be limited to, knowledge of common terms used in the automotive repair field, the ability to identify automotive parts in pictures or written descriptions, and the ability to use standard industry references to look up automotive parts.
- 3) <u>Keeping simple inventory records</u> These questions test for the ability to follow instructions in keeping simple inventory records of different materials received and distributed from a central location. The ability to add, subtract, multiply, and divide will be required. You may have to compute total costs from quantities (number of units) and cost or price per unit. Knowledge of specific record keeping systems and techniques will not be needed.
- 4) <u>Principles and practices of storekeeping and inventory control</u> These questions will test for candidates' knowledge of the principles guiding large scale storekeeping operations and their ability to put them into practice. Some of the areas covered may include analysis of rates of use, the determination of reorder points, choosing locations for the storage of goods, and determining how to handle stock to maximize the efficiency of the operation. Some arithmetic computation may be necessary.
- 5) <u>Supervision</u> These questions test for knowledge of the principles and practices employed in planning, organizing, and controlling the activities of a work unit toward predetermined objectives. The concepts covered, usually in a situational question format, include such topics as assigning and reviewing work; evaluating performance; maintaining work standards; motivating and developing subordinates; implementing procedural change; increasing efficiency; and dealing with problems of absenteeism, morale, and discipline.

<u>NOTICE TO CANDIDATES</u>: The use of calculators is <u>**RECOMMENDED**</u> for this exam. Devices with typewriter keyboards, 'Spell Checkers', 'Personal Digital Assistants', 'Address Books', 'Language Translators', 'Dictionaries', or any similar devices are prohibited.

<u>SENIORITY POINTS</u>: will be added to an eligible's score based on the length of continuous permanent classified service. Points will be calculated as follows: 1 to 6 yrs. service - 1 point; over 6 thru 11 yrs. service - 2 points; etc. A full schedule of points may be obtained by contacting the Department of Human Resources.

<u>LEGAL AUTHORIZATION TO WORK IN THE UNITED STATES</u>: Federal Immigration Law requires employers to verify that all persons hired are legally authorized to work in the United States. <u>CURRENT/PROSPECTIVE MILITARY SERVICE MEMBERS</u>: New York State Law provides for Military Make-up Tests in cases where candidates cannot attend the scheduled test on the published test date due to active military duty. THIS EXAMINATION IS BEING RATED: by the New York State Department of Civil Service in accordance with Section 23-2 of the Civil Service Law. The provisions of the New York State Civil Service Rules and Regulations dealing with the rating and review of examinations will apply to this test. The eligible list resulting from an examination may also be used for appointment to the same title or to any other title deemed to be similar and appropriate.

<u>ALTERNATE TEST DATES</u>: State and local examination policy does permit alternate test dates for certain compelling reasons. For details or to request an alternate test date, contact the Department of Human Resources.

LOCATION OF EXAM SITE: Examinations are held in Mayville unless for reasons beyond our control, we must change the test site.

<u>VETERAN CANDIDATES</u>: Veterans or disabled veterans who are eligible for additional credit must submit an application for veteran's credit with their application for examination or at any time between the dates of their application for examination and the date of the establishment of the resulting eligible list. Applications for veteran's credit are available from this office. Veteran's credits can only be added to a passing score on the examination.

Effective January 1, 1998, the State Constitution was amended to permit a candidate currently in the armed forces to apply for and be conditionally granted veteran's credit in examinations. Any candidate who applies for such credit must provide proof of military status to receive the conditional credit. No credit may be granted after the establishment of the list. It is the responsibility of the candidate to provide appropriate documentary proof indicating that the service was in time of war, as defined in section 85 of Civil Service Law, and that the candidate received an honorable discharge or was released under honorable conditions in order to be certified at a score including veteran's credits.

SECTION 85-a OF THE CIVIL SERVICE LAW: Effective 9/17/02, children of firefighters and police officers killed in the line of duty shall be entitled to receive an additional ten points in a competitive examination for original appointment in the same municipality in which his or her parent has served. If you are qualified to participate in this examination and are a child of a firefighter or police officer killed in the line of duty in this municipality, please inform this office of this matter when you submit your application for examination. A candidate claiming such credit has a minimum of two months from the application deadline to provide the necessary documentation to verify additional credit eligibility. However, no credit may be added after the eligible list has been established.

ADMISSION TO EXAMINATION: Notice to appear for the examination will be conditional, as review of applications for minimum requirements may not be made until after the written test. Call the Chautauqua County Human Resources Office if you have not received your notice 3 days before the date of the examination. You may not be admitted to the examination room without official notice.

<u>RELIGIOUS ACCOMMODATIONS AND OTHER SPECIAL ARRANGEMENTS</u>: Most written tests are held on Saturdays. If you cannot take the test on the announced test date due to a conflict with a religious observance or practice, please contact our office so that we can make arrangements for you to take the test on a different date. Applicants with disabilities who require special arrangements should contact our office by the close of the filing period for the examination.

<u>RATINGS REQUIRED</u>: Tests are rated on a scale of 100 with the passing mark at 70. Unless the announcement states otherwise you must pass the written test and the oral test, if any. Test instructions may further divide the tests into parts and set minimum standards for each part.

<u>VERIFICATION OF QUALIFICATIONS</u>: Candidates may be investigated or called for an interview to determine whether they are qualified for appointment. In addition to meeting specific requirements, candidates must be of good moral character and habits.

MEDICAL EXAMINATION: You may be required to take a medical examination to determine if you are medically and physically capable of performing the duties of the position.
